II. Old Business

A. Approval of Meeting Minutes

III. New Business

A. Subcommittee Report - SBS/GU/WC - Claire reporting

JAPA 310 – Global Understanding – APPROVED

After intensive and spirited discussion, the course was approved (7-2) with a recommendation to either change the title of the course and drop references to the 19th century or to revise the syllabus to cover more of Japanese history (militarization, the post-war economy, etc). Concern was expressed that the current title and syllabus could potentially confuse a student about what to expect from the course. These recommendations will be passed on to the unit. The recommended title was "Cultural Globalization: the Case of Japan."

B. Subcommittee Report - Arts/WC/OC/Humanities - Doug reporting

The subcommittee has recommended that the course be returned, with explicit instructions to rewrite the proposal, specifically addressing the

learning outcomes for the category and how they will be achieved. The subcommittee would also like to know what the essay questions will cover and what the breakdown of assignment will be (how much does each assignment count).

C. IT Learning Outcomes

- Ying recapped the spring IT learning outcomes workshop and will share the information gathered from that session via email.
- The predominant argument was whether the requirement should be more technically focused or to open it up to the disciplines and be more focused on problem solving using technology.
- The issue for the committee to decide is whether or not the ethics component needs to be decoupled from the IT requirement or be integrated into more fully. Consensus is that the current inventory of IT all, IT ethics only, or IT without ethics has led to confusion.
