1. Honors College articulation table discussion (Guest: Jan Allbeck, 1:00-1:15pm)

The curriculum presented are the guidelines that the Honors College uses for students who may leave the Honors College. Its purposes is to help advisors advise students who are leaving and to avoid penalizing the student by taking Honors courses early on. It essentially helps students find where they may get Mason Core credits. Not many students leave, and when they do it is usually early on, so this scenario does not happen often. These courses are processed as sub/waivers, which are signed in the department/college and then to the Associate Provost level. Some of these courses were evaluated during the Assessment process. For example, during assessment, it was determined that the HONS 110 (HONS 302T) courses met the learning outcomes for ENGH 302. The document is not "hidden" but is not public to the students to avoid confusing them. The document is with the advisors so that they can have the best outcomes possible. This doesn't prevent students from leaving the Honors College, but it helps them make the transition with guidance, rather than dropping out alone. Discussion ensued. Members were asked to endorse this plan or continue for another meeting. The Committee approved endorsing this existing plan.
