Just Societies	INTS 319: Contemporary Youth Studies	The committee feels this course is a good fit for Just Societies, but the worksheet needs to be revised for clarity. It seems the content is there, but the assignment map is not clear as to how those assignments will most clearly lead to mastery of the LOs, particularly with the peer engagement piece in LO1b. As written, there is no assessable artifact for meaningful

		engagement with peers. Invitation to meet with Laura Poms to assist with revisions.

Just Societies	WMST 200: Introduction to Women and Gender Studies	The committee feels this course is a good fit for Just Societies, but the worksheet needs to be revised for clarity. It seems the content is there, but the assignment map is not clear as to how those assignments will most clearly lead to mastery of the LOs, particularly with the peer engagement piece in LO1b. As written, there is no assessable artifact for meaningful engagement with peers. Invitation to meet with Laura Poms to assist with revisions.

pust societies	INTO JOJ. JOCIAI JUSTICE INATIALIVES	Societies. However, there should be more evidence of a singular, assessable student artifact for meeting LO1b. For example, the prompt provided for the fast-write does not meet LO1b, as the assignment should illustrate how students meaningfully engaged with peers. Strong proposal otherwise.

Global Contexts	SOCI 332: The Urban World	The committee agreed that this course seemed like a clear fit for the category. Limited discussion as a result, and the committee voted to approve.
		Vote: Approve as is
Just Societies	SOCI 352: Social Problems and Solutions	Positive feedback provided overall, but the assignment map could be strengthened to better defend how LO1b is being addressed. For example, the UnEssay assignment might include meaningful engagement with peers, but as written the assignment doesn't seem to lead to an assessable student artifact that illustrates students meet that outcome. Suggestion to add an additional element, such as a reflection, to meet that.
		Vote: Rollback with revisions and resubmit
Global Contexts	INYO 261: Mentoring Multilingual Learners	Positive feedback from the committee. One suggestion provided about management plan, but this did not interfere with the course's approval.
		Vote: Approve as is
Just Societies	INYO 261: Mentoring Multilingual Learners	Positive feedback from the committee. Outcomes are clearly met, and the course clearly maintains a global perspective. Committee voted to approve.
		Vote: Approve as is
Just Societies	GOVT 103: Introduction to American Government	Positive feedback on the course, but some issues with how LO2b is being evaluated – as written, the committee can't see clearly that strategies for addressing obstacles to justice are being discussed and considered. The CEA assignments are great, for example, but how they will be evaluated to support mastery of the LOs should be better articulated. Invitation to meet with Laura Poms to assist with revisions.

Just Societies	GOVT 134: Grand Challenges to Human Security	Very positive feedback on how the course assignments reflect the LOS. Great use of peer review for meeting LO1B.
		Vote: Approve as is
Just Societies	HIST 272: Survey of Latin American History	Positive feedback on the revisions. One main issue is that the syllabus does not mention the meaningful engagement aspect of the prompt. Course will be approved once updated syllabus is received with correct language.
		Vote: Approve as is, pending minor revisions (syllabus language)
Global Contexts	INTS 417: Human Trafficking and Smuggling	While the course seems like a natural fit for this category, more details are needed on the assignment map. More articulation is needed on the proposal to clarify how the assignments meet the LOs and how they will be assessed. There was additional discussion about the two syllabi (one lists 3 credits, one lists 6). The course management plan could also be further revised. Invitation to meet with Laura Poms to assist with revisions.
Mason Anov	COVE 402: Computing Ethics Law and Policy Comings	Vote: Rollback with revisions and resubmit
Mason Apex	GOVT 492: Computing Ethics, Law and Policy Seminar	Overall, the course seems applicable as a Mason Apex course. However, there is no course management plan included. The committee will need to see and review this plan prior to approval, but the Mason Apex elements are approved.
		Vote: Approve as is, pending the sustainability plan
Writing Intensive	GOVT 492: Computing Ethics, Law and Policy Seminar	Overall, the committee would like to see more attention in the proposal to show "significant instruction". Additional issues with the LO "writing as a process," as there might not be enough time for drafting purpose. The committee also discussed the importance of incorporating peer review for a WI course, and that could be more clearly supported in the proposal. Invitation to meet with Tom Polk for assistance with revisions.

		Vote: Rollback with revisions and resubmit
Mason Apex	NEUR 422: Glutamatergic Systems	The committee had some issue with how the learning outcomes have been rephrased. For example, the rephrasing of LO1 seem to be missing the major concept of "exploring complex issues in an original way." As written then, the LOs do not meet category expectations. Additional issues present regarding the course management plan, as it doesn't seem feasible to change out the course in the event a specific instructor will be unable to teach. Should consider how this might impact students in the event that happen, as it would require another course to be developed and approved. Invitation to meet with Laura Poms to assist with revisions. Vote: Rollback with revisions and resubmit
Global Contexts	CRIM 308: Human Rights and Justice	Positive feedback around the intentionality to develop a framework assignment for multiple modalities/instructors, but as written it remains problematic because it allows for too much flexibility. Content is a good match for both categories, but the proposal needs to more clearly identify how LOs will be met. Additional concerns provided regarding how well the sustainability plan protects the course.
