Social and Behavioral Science	HIST 382: Law and History	<p>The committee felt it was not clear how this course, which focuses on historical and legal contexts, aligns with the SBS Mason Core category. To ensure the course aligns with SBS expectations, the proposal should explicitly identify and integrate relevant SBS theories throughout the course materials. Connections should be more evident in the Rationale and Assignment Map sections of the proposal worksheet as well as in the syllabus. Additionally, it was unclear how the assignment for learning outcome 3 connected to specific SBS concepts, terminology, principles and theories.</p> <p>Vote: Rollback</p>

		There is some ambiguity around the presentation assignment used for learning outcome 2, specifically, what artifact is being submitted for assessment purposes. At present, it's unclear whether presentation slides alone will provide adequate evidence for assessment. As an added note, there was concern about the lack of prerequisites listed for the course. The committee voted to approve administrative review to address these issues.

		The syllabus does not clearly identify the Mason Apex learning outcomes. Additionally, group assignments are being used currently, but there needs to be a way to collect individual student work—particularly for the debate—or consider modifying assignments. Additionally, the Course Management Plan should elaborate on how Mason Core outcomes will be communicated to new faculty and how current faculty will be supported to prevent course drift over time.
